On Thursday, March 22, 2018, the Exchange made amendments to the Position Limit, Position Accountability and Reportable Level Table ("Table") in CME Rulebook Chapter 5 to add aggregate into ratios for the second leg of the Bursa Malaysia Crude Palm Oil – Gasoil Spread Futures which were initially inadvertently excluded. The Exchange also amended the initial spot-month limit effective date language to include the second leg of the contract.
