RE: Weekly Notification of Rule Amendments: Nadex Adds Discretionary Strike Levels in its Daily Gold, Silver, and US Tech 100 Binary Contracts on December 1, 2014 – Submission Pursuant to Commission Regulation §40.6(d)

Dear Mr. Kirkpatrick:

Pursuant to Section 5c(c)(1) of the Commodity Exchange Act, as amended (“Act”), and section §40.6(d) of the regulations promulgated by the Commodity Futures Trading Commission (the “Commission”) under the Act (the “Regulations”), and by the authority granted in Nadex Rule 12, North American Derivatives Exchange, Inc. (“Nadex”, the “Exchange”) hereby provides notice that due to volatility in the underlying markets upon which the Nadex contracts are based, Nadex has added additional strike levels on a discretionary basis in its Daily Gold, Silver, and US Tech 100 Binary Contracts on December 1, 2014. Nadex returned to its regular listing schedule for these contracts on December 2, 2014.

New strikes created December 1, 2014 are set forth in Exhibit A.

Nadex hereby certifies that the additions contained herein comply with the Act, as amended, and the Commission Regulations adopted thereunder.
