Dear Mr. Kirkpatrick:

New York Mercantile Exchange, Inc. (“NYMEX” or “Exchange”) is notifying the Commodity Futures Trading Commission (“CFTC” or “Commission”) that it is self-certifying the expansion of the listing schedule of the Mini ULSD 10ppm Cargoes CIF NWE (Platts) vs. Low Sulphur Gasoil Futures and the ULSD 10ppm Cargoes CIF NWE (Platts) vs. Low Sulphur Gasoil Futures which are listed for trading on CME Globex, the NYMEX trading floor and for submission for clearing through CME ClearPort, effective on Sunday, May 3, 2015 for trade date Monday, May 4, 2015.

The product title, symbol, rule chapters, current listing schedule and amended listing schedule are set forth below.

The Exchange reviewed the designated contract market core principles (“Core Principles”) as set forth in the Commodity Exchange Act (“CEA” or “Act”) and identified that the amendments may have some bearing on the following Core Principles:

- **Availability of General Information:** The Exchange will publish information regarding the amendments via Special Executive Report to notify the marketplace of the changes, and the amended listing schedules will be available on the CME Group website.

- **Daily Publication of Trading Information:** The Exchange shall make public daily information on settlement prices, volume, open interest, and opening and closing ranges for actively traded contracts on the contract market.
- **Execution of Transactions:** The existing futures contracts are dually listed for trading on CME Globex and the NYMEX trading floor and for clearing through the CME ClearPort platform.

Pursuant to Section 5c(c) of the Act and CFTC Regulation 40.6(a), the Exchange hereby certifies that the amendments to the listing schedules of the Mini ULSD 10ppm Cargoes CIF NWE (Platts) vs. Low Sulphur Gasoil Futures and the ULSD 10ppm Cargoes CIF NWE (Platts) vs. Low Sulphur Gasoil Futures contracts comply with the Act, including regulations under the Act. There were no substantive opposing views to this proposal.
