RE: Weekly Notification of Rule Amendments: Nadex Adds Discretionary Strikes on April 19, 20, and 22, 2016 - Submission Pursuant to Commission Reg. §40.6(d)

Dear Mr. Kirkpatrick:

Pursuant to Section 5c(c)(1) of the Commodity Exchange Act, as amended (“Act”), and section §40.6(d) of the regulations promulgated by the Commodity Futures Trading Commission (the “Commission”) under the Act (the “Regulations”), and by the authority granted in Nadex Rule 12, North American Derivatives Exchange, Inc. (“Nadex”, the “Exchange”) hereby provides notice that due to volatility in the underlying markets upon which the Nadex contracts are based, Nadex added additional strike levels on a discretionary basis in its Daily FTSE 100, Silver, and Gold Binary contracts on April 19, 2016, and returned to its regular listing schedule for these contracts on April 20, 2016. Additionally, Nadex added discretionary strike levels in its Daily Crude Oil Binary contracts on April 20, 2016, and returned to its regular listing for these contracts on April 21, 2016. Finally, Nadex listed additional strike levels on a discretionary basis in its Daily US Tech 100 Binary contracts on April 22, 2016. Nadex plans to return to its regular listing for these contracts on April 25, 2016.

Additional strikes are attached hereto in Exhibit A.

Nadex hereby certifies that the additions and amendments contained herein comply with the Act, as amended, and the Commission Regulations adopted thereunder. No substantive opposing views were expressed to Nadex with respect to these additions. Nadex hereby certifies that notice of these events was posted on its website at the time of this filing.
