Pursuant to Commodity Futures Trading Commission ("CFTC" or "Commission") Regulation 40.6(d), the Exchange submits this weekly notification of the following amendments related to product terms and conditions made effective during the week of April 25, 2016.

Effective Sunday, April 24, 2016 for trade date Monday, April 25, 2016, the Exchange added a third serial month expiration to certain Foreign Exchange ("FX") option contracts within the currently established listing cycle. The marketplace was notified via Special Executive Report ("SER") #7617R, which is attached hereto as Exhibit A.

On Tuesday, April 26, 2016, the Exchange approved the application of Classic Transportation & Warehousing located at 1120 36th Street SE, Grand Rapids, MI to be designated as an Approved Warehouse for delivery of Spot Call Nonfat Dry Milk. The marketplace was notified of this approval via MKR# 04-26-16, which is attached hereto as Exhibit B.

On Tuesday, April 26, 2016, the Exchange approved the application of Far West Distributors, Inc. located in Tulare, CA to be designated as an Approved Warehouse for delivery of Spot Call Nonfat Dry Milk. Adding Third Serial Month to Certain CME Foreign Exchange (FX) Option Contracts

(This SER supersedes SER-7617 dated March 21, 2016 and is being issued to include American- and European-style exercise options on Japanese Yen/US Dollar (JPY/USD) futures and American-style exercise options on Euro/Japanese Yen (EUR/JPY) futures, which were not originally included on the list of eligible FX option contracts adding third serial month expirations. No other changes have been made to the original SER.)

Effective Sunday, April 24, 2016 for trade date Monday, April 25, 2016, Chicago Mercantile Exchange Inc. ("CME" or "Exchange") will add a third serial month expiration to the following Foreign Exchange ("FX") option contracts within the currently established listing cycle:

- American- and European-style exercise options on Australian Dollar/US Dollar (AUD/USD), Canadian Dollar/US Dollar (CAD/USD), Swiss Franc/US Dollar (CHF/USD), Euro/US Dollar (EUR/USD), Japanese Yen/US Dollar (JPY/USD), and British Pound/US Dollar (GBP/USD) futures;
- American-style exercise options on Euro/Swiss Franc (EUR/CHF), Euro/British Pound (EUR/GBP), Euro/Japanese Yen (EUR/JPY), Israeli Shekel/US Dollar (ILS/USD), and New Zealand Dollar/US Dollar (NZD/USD) futures; and
- American-style exercise options on Czech Koruna/Euro (CZK/EUR), Czech Koruna/US Dollar (CZK/USD), Hungarian Forint/Euro (HUF/EUR), Hungarian Forint/US Dollar (HUF/USD), Polish Zloty/Euro (PLN/EUR), and Polish Zloty/US Dollar (PLN/USD) futures.

As shown in Appendix A, CME will add the August 2016 serial month expiration effective Monday, April 25 to the above mentioned FX option contracts.

The Exchange lists the above mention FX options for trading on CME Globex and the CME trading floor and for submission for clearing on CME ClearPort.

The Commodity Futures Trading Commission ("CFTC") will be notified of the amendments during the week of May 2, 2016, via the weekly notification procedures set forth in Part 40 of the CFTC Regulations.
