Dear Mr. Kirkpatrick:

Pursuant to Commodity Futures Trading Commission (“CFTC” or “Commission”) Regulation 40.6(d), the Exchange submits this weekly notification of the following amendments related to product terms and conditions made effective during the week of April 24, 2017.

On Tuesday, April 25, 2017, the Exchange was notified that W.C. Heraeus GmbH changed its name to Heraeus Deutschland GmbH & Co. KG. This name change is the result of a restructure. In addition, the Exchange was notified that Heraeus Ltd. changed its name to Heraeus Ltd. Hong Kong. This name change is also the result of a restructure. The marketplace was alerted of these changes via MKR# 04-25-17, which is attached hereto as Exhibit A.

On Tuesday, April 25, 2017, the Exchange was notified that Heraeus Metals New York LLC, producer of Gold brand HERI, changed their brand mark from ‘HERAEUS FEINGOLD (with capital letter “E” preceding the serial number)’ to ‘HERAEUS FEINGOLD (hand holding three roses encircled with “Heraeus Edelmetalle GmbH Hanau”)’. In addition, the Exchange was notified that Heraeus Ltd. Hong Kong, producer of Gold brand HERH, changed their brand mark from ‘HERAEUS FEINGOLD (with capital “H” preceding the serial number)’ to ‘HERAEUS FEINGOLD (hand holding three roses encircled with “Heraeus Edelmetalle Hanau”)’. Lastly, the Exchange was notified that Heraeus Deutschland GmbH & Co. KG, producer of Gold brand HERA with brand mark ‘HERAEUS FEINGOLD (with Heraeus Edelmetalle GmbH-Hanau encircling three roses)’, is no longer producing COMEX eligible gold bars. The marketplace was alerted of these changes via MKR# 04-25-17B, which is attached hereto as Exhibit B.

In accordance with the changes listed above, the Exchange updated the COMEX Rulebook Chapter 7 Charts for “Gold Brands,” which is attached under separate cover as Exhibit C, with amendments blacklined.
