## Re: Consolidation of Open Interest in Certain Physical Environmental Futures and Options Products Submission Pursuant to Section 5c(c)(1) of the Act and Regulation 40.6

Dear Mr. Kirkpatrick:

Pursuant to Section 5c(c)1 of the Commodity Exchange Act, as amended (the "Act") and Commodity Futures Trading Commission ("Commission") Regulation 40.6(a), ICE Futures U.S., Inc. ("Exchange") submits notice to the Commission that, effective as of the close of business May 31, 2019, the Exchange will consolidate open interest in the "named vintage" Physical Environmental futures and options contracts with each contract's "continuous vintage" equivalent, as set forth in Exhibit A.

Currently, the Exchange lists a suite of named vintage and a corresponding suite of continuous vintage futures and options which, in certain contract months, call for delivery of the same renewable energy or solar renewable energy certificates. The two suites of contracts are essentially the same, all economic terms and conditions of the named vintage futures and options are identical to the economic terms and conditions of the corresponding expiration month of the continuous vintage future or option.

As an example, at contract expiration, the terms and conditions of the named vintage May 2020 Connecticut Compliance Renewable Energy Certificate Class 1 Vintage Future - Vintage 2019 ("May20 CC9") contract calls for delivery of Connecticut Class 1 renewable energy certificates ("RECs") representing Class 1 renewable energy and issued by NEPOOL GIS having a vintage or energy year designation that corresponds to the specified vintage of the expiring contract. Therefore, CT Class 1 RECs with a vintage year of 2019 are deliverable under May20 CC9. Similarly, at contract expiration, the terms and conditions of the continuous vintage May 2020 Connecticut Compliance Renewable Energy Certificate Class 1 Future ("May20 CTT") contract also calls for delivery of Connecticut Class 1 RECs representing Class 1 renewable energy and issued by NEPOOL GIS having a vintage or energy year designation that corresponds to the specified vintage of the expiring contract. As such, for the May20 contract month, the named vintage May20 CC9 and the continuous vintage May20 CTT are identical.

Due to the identical nature of the named vintage and continuous vintage futures and options products, and in order to simplify the Exchange's product offering, it intends to consolidate futures and option interest into a single suite and will migrate open interest in the named vintage contracts to the equivalent continuous vintage contracts as of close of business May 31, 2019. To limit the number of

contracts that must to be consolidated, all named vintage contracts which have no open interest and no equivalent continuous vintage contract have been delisted in advance of this consolidation (See Submission Nos. 19-129 and 19-150).

The consolidation is planned to occur as follows: at the close of trading on Friday, May 31, ICE Futures U.S. will cease allowing trading in the named vintage contracts; migrate open interest from the named vintage futures and options contracts to the equivalent continuous vintage futures and options contracts; and, at the opening of trading on Sunday, June 2 (for trade date Monday, June 3), open the continuous vintage futures and options contracts for trading, as normal. By that time, all open interest from the named vintage futures and options contracts will have migrated to the continuous vintage futures and options contracts will have migrated to the continuous vintage futures and options contracts will no longer be made available for trading. The terms and conditions specifications of the continuous vintage futures and options contracts will be unchanged as a result of the open interest consolidation.

Related to the example above, and using open interest as of close of business May 13, 2019, the open interest in May20 CC9 was 4,890 contracts and open interest in May20 CTT was 0. After the open interest consolidation, open interest in May20 CC9 will be 0 and the contract will be delisted. Open interest in the May20 CTT will therefore be 4,890 contracts. The Exchange provides the above as an example, but notes that certain contract months of both named vintage and continuous vintage futures markets contain open interest and the gross position resulting from the open interest consolidation may be subject to position netting on behalf of the position-holder by the relevant clearing firm.

The Exchange issued a Notice on April 22, 2019, advising the market of the details and proposed timeline of the migration. As a result, the Exchange has discussed the open interest migration with market participants and clearing firms.

## **Certifications**

The Exchange is not aware of any opposing views to the open interest consolidation and certifies that the open interest consolidation and delisting of the named vintage futures and options contracts complies with the requirements of the Act and the rules and regulations promulgated thereunder. The Exchange has reviewed the designated contract market core principles ("Core Principles") as set forth in the Act and has determined that the open interest consolidation and delisting complies with the following relevant Core Principles:

**COMPLIANCE WITH RULES:** The positions represented by the continuous vintage open interest will continue to be subject to all relevant Exchange rules, which are enforced by the Market Regulation Department.

**CONTRACTS NOT READILY SUBJECT TO MANIPULATION:** The continuous vintage futures and options contracts are not readily subject to manipulation as they are based on established and liquid underlying cash markets. In addition, trading of the continuous vintage contracts will continue to be monitored by the Market Regulation Department.

**POSITION LIMITS OR ACCOUNTABILITY:** Positions in all continuous vintage futures and options contracts will continue to be subject to the position limits set forth in Resolution No. 2 to Chapter 18. The position limits for the continuous vintage contracts remain unchanged as a result of the open interest consolidation. Positions held in continuous vintage options contracts will continue to be aggregated with positions held in the corresponding continuous vintage futures contract.
