Pursuant to Commodity Futures Trading Commission ("CFTC" or "Commission") Regulations 40.4(b)(5), The Board of Trade of the City of Chicago, Inc. ("CBOT" or "Exchange") is notifying the CFTC that it is self-certifying non-material agricultural rule amendments to CBOT Chapter 7 ("Delivery Rules and Procedures") relating to CBOT KC HRW Wheat Futures (Chapter 14H; Commodity Code KW).

The non-material agricultural rule changes to Chapter 7 (the "Chapter 7 Amendments") are intended to (1) migrate delivery rules, delivery procedures and regularity rules for KC HRW Wheat futures from the futures contract rule chapter and into Chapter 7, consistent with other CBOT physically delivered agricultural futures, and (2) amend such delivery and regularity rules as noted below.

The Chapter 7 Amendments are deemed non-material because the delivery, load-out and regularity rules are being migrated from the Product Chapter (CBOT Submission No. 17-188) and into Exchange Chapter 7 consistent with other grain futures listed on CBOT and certain amendments, as detailed below, are being implemented in support of the implementation of a variable storage rate and change of delivery instrument from warehouse receipt to shipping certificate (CBOT Submission No. 17-134). In addition to being migrated into Chapter 7, the rule governing the approval term for warehouse regularity for KC HRW Wheat is being amended from 1 year to 2 years in line with the term of approval for other grain futures listed on CBOT. Additionally, the warehouse minimum financial obligation is being amended from a requirement of a net worth of \$0.15 per bushel of approved capacity to a minimum total net worth of \$5,000,000. Given that all KC HRW Wheat facilities currently meet all such new financial net worth requirements, the Exchange believes that the Product Chapters Rule Amendments herein are non-material.

The amendments herein shall have no impact on value of open positions in the Contracts.

The Chapter 7 Amendments are being made in conjunction with CBOT Submission No. 17-188, self-certification of non-material agricultural rule amendments to CBOT Chapter 14H ("KC HRW Wheat Futures") contract containing the elimination of delivery rules, delivery procedures and regularity rules for KC HRW Wheat futures from the futures contract rule chapter and into Chapter 7, consistent with other CBOT physically delivered agricultural futures.

The implementation of the Chapter 7 Amendments is contingent on the approval from the CFTC of CBOT Submission No. 17-134, filed May 22, 2017. Submission No. 17-134 requests Commission approval to implement a Variable Storage Rate (VSR) mechanism for KC HRW Wheat and Mini-Sized KC HRW Wheat futures contracts (the "Contracts"), amend the Contracts' delivery instrument and amend the Contracts' last delivery date.

The Chapter 7 Amendments shall take effect upon approval of CBOT Submission No. 17-134 or after the regulatory review period for this filing has expired, whichever is later. Additionally, Chapter 7 Amendments

shall take effect concurrent with the effective date of CBOT Submission No. 17-188 to remove delivery provisions from Chapter 14H and into Chapter 7 as detailed herein.

A summary of the Chapter 7 Amendments is presented below. Appendix A, provided under separate cover, contains Chapter 7 in its entirety with additions underlined and deletions struck through. Appendix B provides a summary chart illustrating the migration of delivery rules from Chapter 14H into Chapter 7 and additional related amendments to Mini-Sized KC HRW Wheat futures (Chapter 14N).

- <u>Chapter 7</u>. With the integration of KC HRW Wheat into Chapter 7, amended references to CBOT Wheat throughout Chapter 7 from "wheat" to "SRW Wheat" in order to distinguish between provision pertaining to the CBOT Wheat futures currently in Chapter 7 and those of KC HRW Wheat.
- 2. <u>Chapter 7, Rule 703 "Regular Warehouses and Shipping Stations"</u>. Shall be applicable to KC HRW Wheat. Incorporated conditions for regularity (conditions for approval) of KC HRW Wheat warehouses from Chapter 14H, Rule 14H16 (which is being deleted), and amended term for regularity from 1 year to 2 years similar to the regularity terms in all other CBOT agricultural products.
- Chapter 7, Rule 703.C. "Load-Out". Migrated load out rules including load out rates, fees, suitable transportation and vomitoxin restrictions from Chapter 14H, Rules 14H13 and 14H17 (which are being deleted).
- 4. <u>Chapter 7, Rule 703.C.D. "Premium Charges"</u>. Incorporated applicability to KC HRW Wheat beginning with VSR implementation.
- 5. <u>Chapter 7, Rule 703.C.F. "Certification of Corn, Soybean and Wheat"</u>. Incorporated reference to certification of U.S. origin for wheat deliverable against KC HRW Wheat (pursuant to Chapters 14H and 14N, Rules 14H04 and 14N04).
- Chapter 7, Rule 703.D. "Failure to Load Out". Shall be applicable to KC HRW Wheat and shall replace Rule 14H13.G.
- 7. <u>Chapter 7, Rule 704 "Inspection"</u>. Incorporated inspection requirements for KC HRW Wheat from Chapter 14H, Rule 14H11 (which is being deleted after the expiration of the December 2017 contract month).
- 8. <u>Chapter 7, Rule 705 "Insurance"</u>. Shall be applicable to KC HRW Wheat (no amendments necessary to Rule 705; the insurance provision for KC HRW Wheat is currently under Chapter 14H, Rule 14H16 which is being deleted).
- 9. <u>Chapter 7, Rule 706 "Variation in Quantity"</u>. Shall be applicable to KC HRW Wheat (no amendments necessary to Rule 706).
- 10. Chapter 7, Rule 708 "Minimum Financial Requirements for Agricultural Regularity". Incorporated from Chapter 14H, Rule 14H16 (which is being deleted), net worth requirements for KC HRW Wheat facilities and aligned those net worth requirements with the net worth requirements currently in place for firms approved for the issuance and registration of shipping certificates including regular firms for CBOT SRW Wheat. Specifically, the financial requirements are being amended from a requirement of a net worth of \$0.15 per bushel of approved capacity to a minimum total net worth of \$5,000,000. All KC HRW Wheat facilities currently meet all such new net worth requirements.
- 11. <u>Chapter 7, Rule 712 "Delivery and Registration"</u>. (1) Incorporated KC HRW Wheat Warehouse Receipt as the deliverable instrument through December 2017 contract month, and, KC HRW Wheat Shipping Certificate as the deliverable instrument beginning with March 2018 contract month; and (2) Rule 712 shall be the governing rule for registration and delivery of registered receipts/certificates for KC HRW Wheat (replaces provisions in Chapter 14H Rules 14H07, 14H08, 14H09, and 14H17).
- 12. <u>Chapter 7, Rule 713 "Delivery Procedures"</u>. Shall be applicable to KC HRW Wheat (no amendments to Rule 713 necessary; current delivery procedures are in Chapter 14H Rules 14H07.A through 14H07.F which are being deleted).
- Chapter 7, Rule 714 "Failure to Deliver". Shall be applicable to KC HRW Wheat (no amendments to Rule 714 necessary). Chapter 14H Rules 14H07.G and 14H14 which contain legacy provisions for failure to deliver are being deleted.

- 14. <u>Chapter 7, Rule 715 "Failure to Accept Delivery or Remit Full Payment"</u>. Shall be applicable to KC HRW Wheat (no amendments to Rule 715 necessary). Chapter 14H Rule 14H14 which contains legacy provisions for failure to accept delivery is being deleted.
- 15. <u>Chapter 7, Interpretation & Special Notices Section</u>. (1) Remove certain obsolete language from the procedures to load out grain; (2) Integrate KC HRW Wheat load out procedures (currently under Interpretation & Special Notices section of Chapter 14H); (3) Implement non-substantive amendments to Exchange references; (4) Incorporate requirements for letters of credit and bond standards for KC HRW Wheat facilities; and (5) Integrate list of approved elevators and capacities for KC HRW Wheat (currently in Interpretation & Special Notices section of Chapter 14H).

Please note that while not referenced in the Chapter 7 Amendments herein, Exchange Rules 701 ("Declaration of Force Majeure"), 702 ("Clearing Member Duties to the Clearing House"), 707 ("Revocation, Expiration or Withdrawal of Regularity"), 716 ("Duties of Clearing Members"), 718 ("Customer Substitution in the Event of Clearing Member Bankruptcy"), 770 ("Delivery Obligation Transfer Procedures") and 771 ("Alternative Notice of Intention to Deliver") will continue to apply to KC HRW Wheat Futures and Mini-Sized KC HRW Wheat Futures contracts.

The Exchange reviewed the designated contract market core principles ("Core Principles") as set forth in the Commodity Exchange Act ("CEA" or "Act") and identified that the following Core Principle may be impacted by this initiative as follows:

Availability of General Information: The Exchange will make publicly available the details of the
amendments herein by publishing a Registrar's Office Notice ("MKR") and a Special Executive
Report ("SER") to the market. The MKR and SER will be available on CME Group's website.

Pursuant to Section 5c(c) of the Act and CFTC Regulations 40.4(a) and 40.5(a), the Exchange hereby certifies that the amendments comply with the Act, including regulations under the Act. There were no substantive opposing views to the proposal by market participants.
