Dear Mr. Kirkpatrick:

Pursuant to Section 5c(c)(1) of the Commodity Exchange Act, as amended, and Commission Regulation 40.6(d), ICE Futures U.S., Inc. (“Exchange”) submits notification to the Commission that, during the preceding week, the Exchange amended subchapters 18B and 18E, as set forth in Exhibit A.

During May 2017, the Exchange enacted a megawatt hour (“MWh”) to megawatt (“MW”) conversion, which affected a number of the Exchange financial power futures and options contracts. Although the below contracts were not directly impacted by that conversion, the Exchange nevertheless amended their naming conventions to more explicitly represent their respective contract sizes.
