Dear Mr. Kirkpatrick:

Pursuant to Commodity Futures Trading Commission (“CFTC” or “Commission”) Regulation 40.6(d), the Exchange submits this weekly notification of the following amendments related to product terms and conditions made effective during the week of June 10, 2019.

Effective June 10, 2019, the Exchange implemented amendments to the Special Price Fluctuation Limits and Daily Price Limits Table (the “Table”) relating to Rule 589. (“Special Price Fluctuation Limits”) of Rulebook Chapter 5 (“Trading Qualifications and Practices”) relating to Interest Rate contracts (the “Contracts”) (collectively, the “Rule Amendments”). Specifically, the Exchange amended the Table to provide clarity regarding the limits during regular trading hours (“RTH”) and extended trading hours (“ETH”). It should be noted that the Rule Amendments are administrative in nature and values of the limits during RTH and ETH of the Contracts remain unchanged.
