Pursuant to Commodity Futures Trading Commission ("CFTC" or "Commission") Regulation 40.6(d), the Exchange submits this weekly notification of the following amendments related to product terms and conditions made effective during the week of June 28, 2021.

On July 1, 2021, the Exchange approved all applications for Declarations of Regularity in Ethanol Facilities. Seven (7) facilities did not renew their regularity status and will not be regular for Ethanol delivery for the period beginning July 1, 2021. The marketplace was alerted of the changes via MKR #07-01-21, which is attached hereto as Exhibit A.
