New York Mercantile Exchange, Inc. (“NYMEX” or “Exchange”) is notifying the Commodity Futures Trading Commission (“CFTC” or “Commission”) that it is self-certifying the expansion of the listing schedule of seventeen (17) Low Sulphur Gasoil related futures contracts, as detailed in the table below, effective on Sunday, July 26, 2015 for trade date Monday, July 27, 2015. These contracts are listed for trading on CME Globex and for submission for clearing through CME ClearPort.

The Exchange reviewed the designated contract market core principles (“Core Principles”) as set forth in the Commodity Exchange Act (“CEA” or “Act”) and identified that the amendments may have some bearing on the following Core Principles:

- **Availability of General Information:** The Exchange will publish information on the changes via Special Executive Report to notify the marketplace of these amendments and through amended listing schedules which will be available on the CME Group website.
- **Daily Publication of Trading Information:** The Exchange shall make public daily information on settlement prices, volume, open interest, and opening and closing ranges for actively traded contracts on the contract market.
- **Execution of Transactions:** The existing futures contracts are listed for trading on CME Globex and for clearing through the CME ClearPort.

Pursuant to Section 5c(c) of the Act and CFTC Regulation 40.6(a), the Exchange hereby certifies that the amendments to the listing schedules of these contracts comply with the Act, including regulations under the Act. There were no substantive opposing views to this proposal.
