Pursuant to Commodity Futures Trading Commission (“CFTC” or “Commission”) Regulation 40.6(d), the Exchange submits this weekly notification of the following amendments related to product terms and conditions made effective during the week of July 6, 2020.

Effective July 9, 2020, the Exchange approved the application of Al Etihad Gold Refinery DMCC (Company logo of small 'E' inside larger 'G' with half circles reading "Al Etihad Gold" above and "Dubai UAE" below) to be good for delivery of gold against the COMEX Gold futures contract. The marketplace was alerted of the approval via MKR #07-09-20, which is attached hereto as Exhibit A.

In accordance with the changes above, the Exchange updated the COMEX Rulebook Chapter 7 “Service Providers” Chart (“Chart”) for “Gold (GC) Brands.” The Chart is attached under separate cover, in blackline format, as Exhibit B.
