RE: Weekly Notification of Rule Amendments: Nadex Amends Strike Interval Width for its US Indices Binary Contracts - Submission Pursuant to Commission Reg. §40.6(d)

Dear Mr. Kirkpatrick:

Pursuant to Section 5c(c)(1) of the Commodity Exchange Act, as amended (“Act”), and Section 40.6(d) of the regulations promulgated by the Commodity Futures Trading Commission (the “Commission”) under the Act (the “Regulations”), North American Derivatives Exchange, Inc. (“Nadex”, the “Exchange”) hereby provides notice that due to increased volatility in the underlying markets upon which the Nadex US Indices contracts are based, Nadex adjusted the strike width for its Daily US Tech 100 Binary contracts from 6 to 12, its Daily Wall Street 30 Binary contracts from 20 to 40, its Daily US 500 Binary contracts from 3 to 6, and its Daily US SmallCap 2000 from 2 to 4. The changes began on August 12, 2019 and continued through August 16, 2019.

Nadex hereby certifies that the additions and amendments contained herein comply with the Act, as amended, and the Commission Regulations adopted thereunder. No substantive opposing views were expressed to Nadex with respect to these additions. Nadex hereby certifies that notice of these events was posted on its website at the time of this filing.
