Pursuant to Commodity Futures Trading Commission ("CFTC" or "Commission") Regulation 40.6(d), the Exchange submits this weekly notification of the following amendments related to product terms and conditions made effective during the week of August 17, 2020.

On August 17, 2020, the Exchange made administrative amendments to CME, CBOT, and NYMEX Rule 539.C. ("Crossing Protocols Table") to delete erroneous references to NYMEX Softs and CME and CBOT Commodity Index Option Contracts as the Exchange does not offer Options on these Contracts. The Crossing Protocols Table is attached under separate cover, as Exhibit A.

Also on August 17, 2020, the Exchange implemented an administrative amendment to the NYMEX Rulebook Chapter 5 Position Limit, Position Accountability and Reportable Level Table (the "Table") in NYMEX Submission No. 20-195 filed on July 30, 2020, to correct a typographical error in the commodity code located in the Spot- Month Aggregate Into Ratio Leg (2) column for the UCO T1 CIF ARA Excluding Duty (PRIMA) vs Low Sulphur Gasoil Futures contract (Commodity Code: USG).
