RE: Weekly Notification of Rule Amendments: Nadex Adds Discretionary Strikes for the Week of September 8, 2015 - Submission Pursuant to Commission Reg. §40.6(d)

Dear Mr. Kirkpatrick:

Pursuant to Section 5c(c)(1) of the Commodity Exchange Act, as amended ("Act"), and section §40.6(d) of the regulations promulgated by the Commodity Futures Trading Commission (the "Commission") under the Act (the "Regulations"), and by the authority granted in Nadex Rule 12, North American Derivatives Exchange, Inc. ("Nadex", the "Exchange") hereby provides notice that due to volatility in the underlying markets upon which the Nadex contracts are based, Nadex added additional strike levels on a discretionary basis in its Daily US Tech 100, Wall Street 30, SmallCap 2000, and US 500 Binary contracts on September 8, 2015. Additionally, Nadex added additional discretionary strikes in its Daily US Tech 100 and Wall Street 30 Binary contracts on September 9, 2015 due to volatility in the underlying markets.

Nadex returned to its regular listing schedule for all contracts on Thursday, September 10, 2015. Additional strikes created for the week of September 8, 2015 are attached hereto in Exhibit A.

Nadex hereby certifies that the additions contained herein comply with the Act, as amended, and the Commission Regulations adopted thereunder. No substantive opposing views were expressed to Nadex with respect to these additions. Nadex hereby certifies that notice of these events was posted on its website at the time of this filing.
