SS - A monthly expiration cycle that lists two serial months expiring on the third Friday of each month.

[1-5][M-F] - Signifies the weekly expiration cycle. Weekly contracts are listed for 7 day terms, by the day of the week and the weekday occurrence in the month. I,J,K,L - Signifies the Friday Future expiration cycle. Friday Future contracts expire on every Friday of the month except the third Friday. Where I is the first Friday, J is the second Friday, K is the fourth Friday, and L is the fifth Friday of the month.

SETTLEMENT TYPE

PHYS - Physical underlying settlement for all components that make up the future listing. CASH - Cash value settlement for all components that make up the future listing.

SETTLEMENT CYCLE

T+1 - For each underlying security, settlement takes place the 1st business day after expiration.

T+2 - For each underlying security, settlement takes place the 2nd business day after expiration.

DIVIDEND EXPOSURE

TRA - The traditional single stock future product has no adjustments made to the previous day's settlement price. NDR - On dividend ex-date, the previous day's settlement price is adjusted down for the amount of the declared distributions.

ACTION

NEW - Initial listing announcement. Properties of this product have changed prior to its effective date. UPDATE - This product has already been announced. Before the effective date, properties of this product have changed. DELETE - This product has already been announced and will not longer be listed.

EFFECTIVE DATE

When Action is NEW or UPDATE, the effective date is the first available date. When Action is DELETE, the effective date is the delisting date.
