Commodity Exchange, Inc. (“COMEX” or “Exchange”) is notifying the Commodity Futures Trading Commission (“CFTC” or “Commission”) that it is self-certifying an amendment to expand the listing schedule of the Aluminum A380 Alloy (Platts) Futures contract (Rulebook Chapter: 122; Commodity Code: A38) (the “Contract”) effective on Sunday, October 30, 2016 for trade date Monday, October 31, 2016 as noted in the table below.

Rulebook Chapter	122
Commodity Code	A38
Current Listing Schedule : CME Globex and CME ClearPort	Monthly contracts listed for 12 consecutive months.
Amended Listing Schedule: CME Globex and CME ClearPort	Monthly contracts listed for the current year and the next calendar year. Monthly contracts for a new calendar year will be added following the termination of trading in the December contract of the current year.

The Exchange reviewed the designated contract market core principles (“Core Principles”) as set forth in the Commodity Exchange Act (“Act” or “CEA”) and identified that the expansion of the listing schedule of the Contract may have some bearing on the following Core Principles:

- Availability of General Information: COMEX will issue a Special Executive Report (“SER”) to the marketplace regarding this amendment. The SER will also be posted on the CME Group website.
- Daily Publication of Trading Information: COMEX will continue to comply with this Core Principle by making public daily information on settlement prices, volume, open interest, and opening and closing ranges for the Contract. This will be accomplished by publishing this information on a daily basis on the Exchange’s website.

Pursuant to Section 5c(c) of the Act and CFTC Regulation 40.6(a), the Exchange hereby certifies that the amendment to the Contract complies with the Act, including regulations under the Act. There were no substantive opposing views to this proposal.
