New York Mercantile Exchange, Inc. ("NYMEX" or "Exchange") is notifying the Commodity Futures Trading Commission ("CFTC" or "Commission") that it is self-certifying the amendments to the listing schedule of certain natural gas (Platts) futures and options contracts (the "Contracts"), as set forth in Appendix A, attached under separate cover, such that the last listed contract month shall be December 2021. As such, no additional contract months shall be added to the Contracts' listing schedule and trading curve. Amendments to the listing schedule of the Contracts will be effective on Monday, October 30, 2017 for trade date Tuesday, October 31, 2017.

The Contracts are listed for trading on CME Globex and for submission for clearing through CME ClearPort.

<u>Daily Publication of Trading Information</u>: NYMEX will continue to comply with this Core Principle by making public daily information on settlement prices, volume, open interest, and opening and closing ranges for the Contracts. This will be accomplished by publishing this information on a daily basis on the Exchange's website.

Pursuant to Section 5c(c) of the Act and CFTC Regulation 40.6(a), the Exchange hereby certifies that the amendments to the Contracts comply with the Act, including regulations under the Act. There were no substantive opposing views to this proposal.
