RE: Weekly Notification of Rule Amendments: Nadex Adds Discretionary Strike Levels in its Binary Contracts on September 25, 2014 – Submission Pursuant to Commission Regulation §40.6(d)

Dear Mr. Kirkpatrick:

Pursuant to Section 5c(c)(1) of the Commodity Exchange Act, as amended ("Act"), and section §40.6(d) of the regulations promulgated by the Commodity Futures Trading Commission (the "Commission") under the Act (the "Regulations"), and by the authority granted in Nadex Rule 12, North American Derivatives Exchange, Inc. ("Nadex", the "Exchange") hereby provides notice that it has added additional strike levels on a discretionary basis in its Daily US Tech 100, Wall Street 30, US 500, and US SmallCap 2000 Binary Contracts on September 25, 2014, due to volatility in the underlying markets on that day. Nadex returned to its regular listing schedule for these contracts on September 26, 2014.

New strikes created on trade date September 25, 2014 are set forth in Exhibit A.

Nadex hereby certifies that the additions contained herein comply with the Act, as amended, and the Commission Regulations adopted thereunder.
