Dear Mr. Kirkpatrick:

The Commodity Exchange, Inc. (“COMEX” or the “Exchange”) is notifying the Commodity Futures Trading Commission (“CFTC” or the “Commission”) that it is self-certifying amendments to the COMEX Position Limit, Position Accountability and Reportable Level Table (the “Table”) located in the Interpretations and Special Notices Section of Chapter 5 of the COMEX Rulebook effective on November 14, 2016. A summary of the amendments is provided below.

- Gold and Silver Options (standard and weekly) and E-micro Gold Futures: The Exchange is amending the reportable levels to render them consistent with those of the respective underlying parent futures contracts.
- Copper Financial Futures and Average Price Option contracts: The Exchange is amending the description of the spot month effective date for clarification purposes only. This amendment is strictly administrative in nature and does not alter the current effective date of the spot month limit.

The amended Table is set forth in Appendix A (under separate cover), with additions underscored and deletions overstruck.

The Exchange reviewed the designated contract market core principles (“Core Principles”) as set forth in the Commodity Exchange Act (“Act”) and identified that the amendments to the Table may have some bearing on the following Core Principle:

Availability of General Information:

In order to ensure that market participants are apprised of the aforementioned amendments, the Exchange will issue a CME Group Market Surveillance Notice to the marketplace notifying them of the implementation of these amendments in advance of the amendments becoming effective. The issuance of the Market Surveillance Notice constitutes compliance with this Core Principle.

The Exchange certifies that the amendments to the Table comply with the Act and regulations thereunder. There were no opposing views to the amendments to the Table.
