New York Mercantile Exchange, Inc. ("NYMEX") and Commodity Exchange, Inc. ("COMEX) (collectively, the "Exchanges") are notifying the Commodity Futures Trading Commission ("CFTC" or "Commission") that they are self-certifying amendments to the rules relating to the NYMEX Coal, Natural Gas, and NYMEX and COMEX Metals option contracts (the "Contracts") effective on Sunday, November 13, 2016 for trade date Monday, November 14, 2016.

The amendments will: (1) amend the strike price listing rules and direct that the information regarding Exchanges strike prices be consolidated and housed in the Strike Price Listing Procedures Table ("Table") located in NYMEX/COMEX Rule 300.20 ("Strike Price Listing Procedures") in NYMEX/COMEX Chapter 300 ("Options Contracts"); (2) align the CME Globex listing schedule with the trading floor and CME ClearPort for the NYMEX products (see table below); and (3) provide administrative, non-substantive changes to the Contracts.
