Pursuant to Section 5c(c) of the Commodity Exchange Act and Section 40.2(a) of the regulations of the Commodity Futures Trading Commission, KalshiEX LLC (Kalshi), a registered DCM, hereby notifies the Commission that it is self-certifying the "Will <candidate> be elected President of Uruguay pursuant to the 2024 Presidential election?" contract (Contract). CONCISE EXPLANATION AND ANALYSIS OF THE PRODUCT AND ITS COMPLIANCE WITH APPLICABLE PROVISIONS OF THE ACT, INCLUDING CORE PRINCIPLES AND THE COMMISSION'S REGULATIONS THEREUNDER

Pursuant to Commission Rule 40.2(a)(3)(v), the following is a concise explanation and analysis of the product and its compliance with the Act, including the relevant Core Principles (discussed in Appendix E), and the Commission's regulations thereunder.

I. Introduction

The "Will <candidate> be elected President of Uruguay pursuant to the 2024 Presidential election?" Contract is a contract relating to the person which wins the Uruguayan presidential runoff election in November 2024.

Further information about the Contract, including an analysis of its risk mitigation and price basing utility, as well as additional considerations related to the Contract, is included in Confidential Appendices C, D, and E.

Pursuant to Section 5c(c) of the Act and CFTC Regulations 40.2(a), the Exchange hereby certifies that the listing of the Contract complies with the Act and Commission regulations under the Act.

General Contract Terms and Conditions: The Contract operates similar to other event contracts that the Exchange lists for trading. The minimum price fluctuation is \$0.01 (one cent). Price bands will apply so that Contracts may only be listed at values of at least \$0.01 and at most \$0.99. Further, the Contract is sized with a one-dollar notional value and has a minimum price fluctuation of \$0.01 to enable Members to match the size of the contracts purchased to their economic risks. As outlined in Rule 5.12 of the Rulebook, trading shall be available at all times outside of any maintenance windows, which will be announced in advance by the Exchange. Members will be charged fees in accordance with Rule 3.6 of the Rulebook. Fees, if they are charged, are charged in such amounts as may be revised from time to time to be reflected on the Exchange's Website. A new Source Agency can be added via a Part 40 amendment. All instructions on how to access

the Underlying are non-binding and are provided for convenience only and are not part of the binding Terms and Conditions of the Contract. They may be clarified at any time. Furthermore, the Contract's payout structure is characterized by the payment of an absolute amount to the holder of one side of the option and no payment to the counterparty. During the time that trading on the Contract is open, Members are able to adjust their positions and trade freely. The Expiration Value and Market Outcome are determined at or after Market Close. The market is then settled by the Exchange, and the long position holders and short position holders are paid according to the Market Outcome. In this case, "long position holders" refers to Members who purchased the "Yes" side of the Contract and "short position holders" refers to Members who purchased the "No" side of the Contract. If the Market Outcome is "Yes," meaning that an event occurs that is encompassed within the Payout Criterion, then the long position holders are paid an absolute amount proportional to the size of their position and the short position holders receive no payment. If the Market Outcome is "No," then the short position holders are paid an absolute amount proportional to the size of their position and the long position holders receive no payment. Specification of the circumstances that would trigger a Market Outcome of "Yes" are included below in the section titled "Payout Criterion" in Appendix A.

APPENDIX A – CONTRACT TERMS AND CONDITIONS

Official Product Name: "Will <candidate> be elected President of Uruguay pursuant to the 2024 Presidential election?"

Rulebook: URUGUAYPRES

URUGUAYPRES

Scope: These rules shall apply to this contract.

Underlying: The Underlying for this Contract is online reporting from the Source Agencies regarding the identity of the winner of the 2024 Uruguayan presidential election. Revisions to the Underlying made after Expiration will not be accounted for in determining the Expiration Value.

Source Agency: The Source Agencies are *The New York Times*, *The Guardian*, and the Associated Press.

Type: The type of Contract is an Event Contract.

Issuance: After the initial Contract, Contract iterations will be listed on an as-needed basis at the discretion of the Exchange and corresponding to the risk management needs of Members.

<andidate>: Kalshi may list iterations of the Contract with <candidate> values corresponding to potential candidates for the presidency of Uruguay. These will be sourced from major political media, such as the Source Agencies.

Payout Criterion: The Payout Criterion for the Contract encompasses the Expiration Values that the winner of 2024 Uruguayan presidential election is <a href="candid

Minimum Tick: The Minimum Tick size for the referred Contract shall be \$0.01.

Position Limit: The Position Limit for the \$1 referred Contract shall be \$7,000,000 per strike, per Member.

Last Trading Date: The Last Trading Date of the Contract will be the same as the Expiration Date. The Last Trading Time will be the same as the Expiration Time.

Settlement Date: The Settlement Date of the Contract shall be no later than the day after the Expiration Date, unless the Market Outcome is under review pursuant to Rule 7.1.

Expiration Date: The Expiration Date of the Contract shall be the sooner of the date of the second 10:00 AM ET following the occurrence of an event that is encompassed in the Payout Criterion or six months after the popular election for the Presidency.

Expiration time: The Expiration time of the Contract shall be 10:00 AM ET.

Settlement Value: The Settlement Value for this Contract is \$1.00.

Expiration Value: The Expiration Value is the value of the Underlying as documented by the Source Agency on the Expiration Date at the Expiration time.

Contingencies: Before Settlement, Kalshi may, at its sole discretion, initiate the Market Outcome Review Process pursuant to Rule 6.3(c) of the Rulebook.

APPENDIX B - TRADING PROHIBITIONS

In addition to the general prohibition against trading on material nonpublic information, the Exchange will be instituting additional prohibitions for trading the PRESURUGUAY contract. Non-U.S. residents are already prohibited from trading on Kalshi's Contract. Nonetheless, the following individuals will be prohibited from trading:

- Holders of national and regional public office, including the President and Vice President of Uruguay, Members of the General Assembly of Uruguay (both Senators and Representatives), and elected departmental and municipal officials.
- Paid campaign staffers on presidential campaigns.
- Anyone working in a vote-tallying capacity, or who has the potential ability to observe official vote counts before they are public.
- Third-party vendors and contractors (and employees thereof) involved in electoral campaigns.
- Paid employees of Uruguayan political parties, including but not limited to the National Party (Partido Nacional), the Broad Front (Frente Amplio), the Colorado Party (Partido Colorado), the Independent Party (Partido Independiente), and Open Cabildo (Cabildo Abierto).
- Paid employees of major polling organizations. This prohibition does not apply to all
 employees of an organization that contains a polling division (e.g., the prohibition does
 not apply to all employees of a university that conducts polling). The Exchange shall
 determine which polling organizations constitute "major" and may modify that
 determination at any time, and will post publicly a list of those organizations on its
 website.
- Employees of major Uruguayan media organizations (including, but not necessarily exclusive to, El País, El Observador, La República, and Búsqueda). The Exchange shall determine which media organizations constitute "major" and may modify that determination at any time, and will post publicly a list of those organizations on its website.
- All staff of the Office of the President and Vice President.
- All staff of the General Assembly and its members.
- All staff of the Supreme Court of Uruguay and its Justices.
