RE: Weekly Notification of Rule Amendments: Nadex Amends Strike Interval Width for its Daily US Tech 100 Binary Contracts - Submission Pursuant to Commission Reg. §40.6(d)

Dear Mr. Kirkpatrick:

Pursuant to Section 5c(c)(1) of the Commodity Exchange Act, as amended ("Act"), and section §40.6(d) of the regulations promulgated by the Commodity Futures Trading Commission (the "Commission") under the Act (the "Regulations"), North American Derivatives Exchange, Inc. ("Nadex", the "Exchange") hereby provides notice that due to decreased volatility in the underlying markets upon which the Nadex US Tech 100 contracts are based, Nadex adjusted the strike width for its Daily US Tech 100 Binary contracts from 4 to 6, beginning on trade date October 30, 2018 and continuing November 2, 2018. Nadex plans to return to the regular strike width for trade date Monday, November 5, 2018.

Nadex hereby certifies that the additions and amendments contained herein comply with the Act, as amended, and the Commission Regulations adopted thereunder. No substantive opposing views were expressed to Nadex with respect to these additions. Nadex hereby certifies that notice of these events was posted on its website at the time of this filing.
