Dear Mr. Kirkpatrick:

The New York Mercantile Exchange, Inc. (“NYMEX” or “Exchange”) is notifying the Commodity Futures Trading Commission (“CFTC” or “Commission”) that it is self-certifying the expansion of the listing schedule of the Japan Crude Cocktail (Detailed) Futures contract (the “Contract”) for trading on CME Globex electronic trading platform and for submission for clearing via CME ClearPort, effective Sunday, November 24, 2019 for trade date Monday November 25, 2019 as more specifically described in the table below.

Current Listing Schedule	Monthly contracts listed for the current year and the next 2 calendar years. Monthly contracts for a new calendar year will be added following the termination of trading in the December contract of the current year.
Expanded Listing Schedule	Monthly contracts listed for the current year and the next 4 calendar years. Monthly contracts for a new calendar year will be added following the termination of trading in the December contract of the current year.

The Exchange reviewed the designated contract market core principles (“Core Principles”) as set forth in the Commodity Exchange Act (“CEA”) and staff identified that the expansion of the listing schedule of the Contract may have some bearing on the following Core Principles:

- **Compliance with Rules:** The Exchange shall continue its normal practice to establish, monitor, and enforce compliance with the rule of the Contract.
- **Availability of General Information:** The Exchange will publish a Special Executive Report (“SER”) to advise the marketplace of the expansion of the listing schedule. The SER will also be posted on the CME Group website.

- **Execution of Transactions:** This change will not impede the Exchange's ability as a designated contract market to provide a competitive, open, and efficient market mechanism for executing transactions of the Contract.

Pursuant to Section 5c(c) of the Act and CFTC Regulation 40.6(a), the Exchange hereby certifies that the expansion of the listing schedule of the Contract complies with the Act, including regulations under the Act. There were no substantive opposing views to this proposal.
