Chicago Mercantile Exchange Inc. (“CME” or “Exchange”) is notifying the Commodity Futures Trading Commission (“CFTC” or “Commission”) that it is self-certifying the expansion of the listing schedule of the MPC SONIA Futures contract (the “Contract”) for trading on the CME Globex electronic trading platform and for submission for clearing via CME ClearPort effective on Sunday, December 2, 2018 for traded date Monday, December 3, 2018 as noted in the table below.

At present, the Exchange lists for trading and clearing, at any given time, futures for expiry on the nearest four scheduled Monetary Policy Committee (“Committee”) meeting dates. The Exchange shall expand the listing schedule so as to list futures for expiry on additional confirmed Committee dates, subject to the availability of such confirmed Committee dates, as published by the Bank of England.

The Exchange has reviewed the designated contract market core principles (“Core Principles”) as set forth in the Commodity Exchange Act (“CEA” or the “Act”) and has identified that this action bears upon the following Core Principle:

- **Availability of General Information:** The Exchange will publish a Special Executive Report (“SER”) to the marketplace regarding these amendments. The SER will also be posted on the CME Group website.
- **Daily Publication of Trading Information:** The Exchange will continue to comply with this Core Principle by making public daily information on settlement prices, volume, open interest, and opening and closing ranges for the Contract. This will be accomplished by publishing this information on a daily basis on the Exchange’s website.

Pursuant to Section 5c(c) of the Act and CFTC Regulation 40.6(a), the Exchange hereby certifies that the amendment to the Contract complies with the Act, including regulations under the Act. There were no substantive opposing views to this proposal.
