New York Mercantile Exchange, Inc. ("NYMEX" or "Exchange") is notifying the Commodity Futures Trading Commission ("CFTC" or "Commission") that it is self-certifying amendments to the rules relating to the Crude Oil, Refined and Freight option contracts (the "Contracts") effective on Sunday, December 4, 2016 for trade date Monday, December 5, 2016.

The amendments will: (1) amend the strike price listing rules and direct that the information regarding Exchanges strike prices be consolidated and housed in the Strike Price Listing Procedures Table ("Table") located in NYMEX Rule 300.20 ("Strike Price Listing Procedures") in NYMEX Chapter 300 ("Options Contracts"); (2) align the CME Globex listing schedule with the trading floor and CME ClearPort (see table below); and (3) provide administrative, non-substantive changes to the Contracts.

<u>Execution of Transactions</u>: The amendments provide that the Contracts will have aligned listing schedules for CME Globex electronic trading platform, the trading floor and CME ClearPort.

<u>Daily Publication of Trading Information</u>: The Exchange will continue to publish contract trading volumes, open interest levels, and price information daily on its website and through quote vendors for the Contracts.

Pursuant to Section 5c(c) of the Act and CFTC Regulation 40.6(a), the Exchange hereby certifies that the amendments to the Contracts complies with the Act, including regulations under the Act. There were no substantive opposing views to this proposal.
