RE: Weekly Notification of Rule Amendments: Nadex Adds Discretionary Strike Levels in its Daily US Indices, Germany 30, and Gold Binary Contracts on October 31, 2014 – Submission Pursuant to Commission Regulation §40.6(d)

Dear Mr. Kirkpatrick:

Pursuant to Section 5c(c)(1) of the Commodity Exchange Act, as amended ("Act"), and section §40.6(d) of the regulations promulgated by the Commodity Futures Trading Commission (the "Commission") under the Act (the "Regulations"), and by the authority granted in Nadex Rule 12, North American Derivatives Exchange, Inc. ("Nadex", the "Exchange") hereby provides notice that due to volatility in the underlying markets upon which the Nadex contracts are based, Nadex has added additional strike levels on a discretionary basis in its Daily US Tech 100, US 500, Wall Street 30, US SmallCap 2000, Germany 30, and Gold Binary Contracts on October 31, 2014. Nadex plans to return to its regular listing schedule for these contracts on Monday, November 3, 2014.

New strikes created October 31, 2014 are set forth in Exhibit A.

Nadex hereby certifies that the additions contained herein comply with the Act, as amended, and the Commission Regulations adopted thereunder.
