Chicago Mercantile Exchange Inc. ("CME" or "Exchange") is notifying the Commodity Futures Trading Commission ("CFTC" or "Commission") that it is self-certifying the expansion of the listing schedule of S&P 500® Annual Dividend Index Futures contract (CME Rulebook: 365, CME Globex Code: SDA; Clearing Code: SDA; CME ClearPort Code: SDA) (the "Contract"), effective Sunday, December 18, 2016, for trade date of Monday, December 19, 2016.

Currently, the Exchange lists for trading such Contracts for expiry on the third Friday of each of the nearest six Decembers. As of Sunday, December 18, 2016, the Exchange shall expand listings to include, at any given time, such Contracts for expiry on the third Friday of each of the 11 nearest Decembers.

 Principle, CME will issue a Special Executive Report ("SER") to the marketplace regarding these
 amendments. The SER will be posted on the CME Group website.

Pursuant to Section 5c(c) of the Act and CFTC Regulation 40.6 (a), the Exchange hereby certifies that the expansion of the listing schedule of the Contract complies with the Act, including regulations under the Act. There were no substantive opposing views to this proposal.
