CONCISE EXPLANATION AND ANALYSIS OF THE PRODUCT AND ITS COMPLIANCE WITH APPLICABLE PROVISIONS OF THE ACT, INCLUDING CORE PRINCIPLES AND THE COMMISSION'S REGULATIONS THEREUNDER

Pursuant to Commission Rule 40.2(a)(3)(v), the following is a concise explanation and analysis of the product and its compliance with the Act, including the relevant Core Principles (discussed in Appendix E), and the Commission's regulations thereunder.

I. Introduction

The "Will <party> win the most seats in the 2025 Albanian parliamentary election?" Contract is a contract relating to the party which will win the most seats in the next Albanian parliamentary election.

Pursuant to Section 5c(c) of the Act and CFTC Regulations 40.2(a), the Exchange hereby certifies that the listing of the Contract complies with the Act and Commission regulations under the Act.

General Contract Terms and Conditions: The Contract operates similar to other event contracts that the Exchange lists for trading. The minimum price fluctuation is \$0.01 (one cent). Price bands will apply so that Contracts may only be listed at values of at least \$0.01 and at most \$0.99. Further, the Contract is sized with a one-dollar notional value and has a minimum price fluctuation of \$0.01 to enable Members to match the size of the contracts purchased to their economic risks. As outlined in Rule 5.12 of the Rulebook, trading shall be available at all times outside of any maintenance windows, which will be announced in advance by the Exchange. Members will be charged fees in accordance with Rule 3.6 of the Rulebook. Fees, if they are charged, are charged in such amounts as may be revised from time to time to be reflected on the Exchange's Website. A new Source Agency can be added via a Part 40 amendment. All instructions on how to access the Underlying are non-binding and are provided for convenience only and are not part of the binding Terms and Conditions of the Contract. They may be clarified at any time. Furthermore, the Contract's payout structure is characterized by the payment of an absolute amount to the holder of one side of the option and no payment to the counterparty. During the time that trading on the Contract is open, Members are able to

adjust their positions and trade freely. The Expiration Value and Market Outcome are determined at or after Market Close. The market is then settled by the Exchange, and the long position holders and short position holders are paid according to the Market Outcome. In this case, "long position holders" refers to Members who purchased the "Yes" side of the Contract and "short position holders" refers to Members who purchased the "No" side of the Contract. If the Market Outcome is "Yes," meaning that an event occurs that is encompassed within the Payout Criterion, then the long position holders are paid an absolute amount proportional to the size of their position and the short position holders are paid an absolute amount proportional to the size of their position and the long position holders receive no payment. Specification of the circumstances that would trigger a Market Outcome of "Yes" are included below in the section titled "Payout Criterion" in Appendix A.

APPENDIX A – CONTRACT TERMS AND CONDITIONS

Official Product Name: "Will <party> win the most seats in the 2025 Albanian parliamentary election?"

Rulebook: ALBANIAPARTY

ALBANIAPARTY

Scope: These rules shall apply to this contract.

Underlying: The Underlying for this Contract is the makeup of the Albanian parliament following the 2025 Albanian parliamentary election. Revisions to the Underlying made after Expiration will not be accounted for in determining the Expiration Value.

Source Agency: The Source Agencies are the Albanian parliament and Politico EU.

Type: The type of Contract is an Event Contract.

Issuance: After the initial Contract, Contract iterations will be listed on an as-needed basis at the discretion of the Exchange and corresponding to the risk management needs of Members.

<political party>: Kalshi may list iterations of the Contract with <political party> values corresponding to political parties, including (without limitation) the Socialist Party, Democratic Party, Party for Justice, Integration and Unity, Freedom Party of Albania, and the Social Democratic Party of Albania.

Payout Criterion: The Payout Criterion for the Contract encompasses the Expiration Values that the winner of the most seats in the 2025 Albanian parliamentary election in parliament is <political party>.

Minimum Tick: The Minimum Tick size for the referred Contract shall be \$0.01.

Position Accountability Level: The Position Accountability Level for the Contract shall be \$25,000 per strike, per Member.

Last Trading Date: The Last Trading Date of the Contract will be the same as the Expiration Date. The Last Trading Time will be the same as the Expiration time.

Settlement Date: The Settlement Date of the Contract shall be no later than the day after the Expiration Date, unless the Market Outcome is under review pursuant to Rule 7.1.

Expiration Date: The latest Expiration Date of the Contract shall be six months after the scheduled election. If the event occurs, expiration will be moved to an earlier date and time in accordance with Rule 7.2.

Expiration time: The Expiration time of the Contract shall be 10:00 AM ET.

Settlement Value: The Settlement Value for this Contract is \$1.00.

Expiration Value: The Expiration Value is the value of the Underlying as documented by the Source Agency on the Expiration Date at the Expiration time.

Contingencies: Before Settlement, Kalshi may, at its sole discretion, initiate the Market Outcome Review Process pursuant to Rule 6.3(d) of the Rulebook. If an Expiration Value cannot be determined on the Expiration Date, Kalshi has the right to determine payouts pursuant to Rule 6.3(b) in the Rulebook.

APPENDIX B - TRADING PROHIBITIONS

In addition to the general prohibition against trading on material nonpublic information, the Exchange will be instituting additional prohibitions for trading the ALBANIAPARTY contract. Non-U.S. residents are already prohibited from trading on Kalshi's Contract. Nonetheless, the following individuals will be prohibited from trading:

- Holders of national and local public office, including Members of the Albanian Parliament (Kuvendi i Shqipërisë), members of local councils, and elected officials of municipal governments, such as mayors, deputy mayors, and city councilors.
- Paid campaign staffers on national or local election campaigns.
- Anyone working in a vote-tallying capacity, or who has the potential ability to observe
 official vote counts before they are public.
- Third-party vendors and contractors (and employees thereof) of parliamentary or local campaigns.
- Paid employees of Albanian political parties, including but not limited to the Socialist Party of Albania (PS), Democratic Party of Albania (PD), Socialist Movement for Integration (LSI), Party for Justice, Integration and Unity (PDIU), Social Democratic Party of Albania (PSD), Republican Party of Albania (PR), and other registered political parties.
- Paid employees of major polling organizations. This prohibition does not apply to all
 employees of an organization that contains a polling division (e.g., the prohibition does
 not apply to all employees of a university with a polling department). The Exchange shall
 determine which polling organizations constitute "major" and may modify that
 determination at any time and will post publicly a list of those organizations on its
 website.
- Employees of major Albanian media organizations (including, but not necessarily exclusive to, Top Channel, TV Klan, Vizion Plus, Ora News, News24, Panorama, Gazeta Shqiptare, Shekulli, Albanian Daily News, and RTSH). The Exchange shall determine which media organizations constitute "major" and may modify that determination at any time and will post publicly a list of those organizations on its website.
- All staff of the Albanian Parliament and its members.
- All staff of the Prime Minister's Office and the Presidential Administration.
- All staff of senior government officials' offices, such as Deputy Prime Ministers, Ministers, Deputy Ministers, and other cabinet officials.
- All staff of the Supreme Court of Albania and the Constitutional Court, as well as their Justices.
