RE: Rule Certification: Nadex Amends Hours for the Week of December 27, 2021 and Announces the 2022 Holidays – Submission Pursuant to Commission Regulation §40.6(a)

Dear Mr. Kirkpatrick:

Pursuant to Section 5c(c)(1) of the Commodity Exchange Act, as amended (the "Act"), and §40.6(a) of the regulations promulgated by the Commodity Futures Trading Commission (the "Commission") under the Act, North American Derivatives Exchange, Inc. ("Nadex") hereby submits to the Commission its intent to amend its Exchange and listing hours for the week of December 27, 2021. Additionally, Nadex announces the 2022 holidays for which Nadex may adjust listing hours for, or not list, all or some of its contracts. Any changes to listing hours or closures will be posted on the Notices page of the Nadex website ahead of the holiday.

Nadex has not identified any DCO or DCM Core Principles that would be negatively affected by the change to the Exchange and listing hours for the week of December 27, 2021 or the 2022 holidays.

Pursuant to the 10-day filing period under Regulation 40.6(a)(3), the amendments will become effective December 27, 2021.

Amendments to the listing schedule, as well as the 2022 holidays, are set forth in Exhibit A.

EXHIBIT A

Nadex will observe the following modified holiday schedule for the week of December 27, 2021:

Monday, December 27, 2021: The Exchange will observe regular business hours and contract listing. No Weekly FTSE will be listed this week. Weekly Japan 225 and Germany 40 listed on this day will expire on Thursday. All other Weekly contracts listed on this trade date will expire on Friday, December 31, 2021 or their regular expiration times.

Tuesday, December 28, 2021: The Exchange will observe regular business hours and contract listings.

Wednesday, December 29, 2021: The Exchange will observe regular business hours and contact listings.

Thursday, December 30, 2021: The Exchange will observe regular business hours and contract listings.

Friday, December 31, 2021: The Exchange will observe regular business hours and contract listings for a regular Friday schedule with the following exceptions:

- No Japan 225, Germany 40, or FTSE 100 contracts will be offered on this day;
- All other Indices contracts will open and close at their regular times;
- All Commodities contracts will open and close at their regular times;
- All Currency contracts will open and close at their regular times;
- The Exchange will close at 4:15pm ET.
