RE: Weekly Notification of Rule Amendments: Nadex Adds Discretionary Strikes for December 8, 9, and 11, 2015 - Submission Pursuant to Commission Reg. §40.6(d)

Dear Mr. Kirkpatrick:

Pursuant to Section 5c(c)(1) of the Commodity Exchange Act, as amended ("Act"), and section §40.6(d) of the regulations promulgated by the Commodity Futures Trading Commission (the "Commission") under the Act (the "Regulations"), and by the authority granted in Nadex Rule 12, North American Derivatives Exchange, Inc. ("Nadex", the "Exchange") hereby provides notice that due to volatility in the underlying markets upon which the Nadex contracts are based, Nadex added additional strike levels on a discretionary basis in its Daily Wall Street 30, US Tech 100, US 500, and Germany 30 Binary contracts on December 8, 2015. Nadex returned to its regular listing for these contracts on December 9, 2015. Nadex also added discretionary strikes in its Daily Bitcoin and Intraday 2-Hour Gold and Silver Binary contracts on December 9, 2015. Nadex returned to its regular listing schedule for these contracts on December 10, 2015. Finally, Nadex listed discretionary strikes in its Daily Germany 30, US 500, US Tech 100, Wall Street 30, and Bitcoin Binary contracts on December 11, 2015 due to volatility in the underlying market upon which this contract is based. Nadex plans to return to its regular listing schedule for these contracts on December 14, 2015. Additional strikes are attached hereto in Exhibit A.

Nadex hereby certifies that the additions and amendments contained herein comply with the Act, as amended, and the Commission Regulations adopted thereunder. No substantive opposing views were expressed to Nadex with respect to these additions. Nadex hereby certifies that notice of these events was posted on its website at the time of this filing.
