Pursuant to Commodity Futures Trading Commission ("CFTC" or "Commission") Regulation 40.6(d), the Exchange submits this weekly notification of the following amendments related to product terms and conditions effective during the week of December 7, 2020.

On December 8, 2020, the Exchange corrected an administrative error in the CME Position Limit, Position Accountability and Reportable Level Table (the "Table"). The Exchange corrected the missing commodity codes in the Single Month Aggregate Into Futures Equivalent Leg (1) column and the All Month Aggregate Into Futures Equivalent Leg (1) column for the Bitcoin Futures and Options on Bitcoin Futures. These amendments to the Table are provided under separate cover in Exhibit A in blackline format.

On December 9, 2020, the Exchange made additional administrative amendments to the Table, to correct typographical errors in the contract type located in column F of the Table for 71 weather option contracts. Specifically, the Exchange corrected the Type from "Am. Option" to "Eu. Option" to correctly represent the option type. These amendments to the Table are provided under separate cover in Exhibit B in blackline format.
