RE: Weekly Notification of Rule Amendments: Nadex Adds Discretionary Strike Levels in its Daily US Tech 100, Wall Street 30, US SmallCap 2000, US 500, and Bitcoin Binary Contracts During Week of December 8, 2014 – Submission Pursuant to Commission Regulation §40.6(d)

Dear Mr. Kirkpatrick:

Pursuant to Section 5c(c)(1) of the Commodity Exchange Act, as amended ("Act"), and section §40.6(d) of the regulations promulgated by the Commodity Futures Trading Commission (the "Commission") under the Act (the "Regulations"), and by the authority granted in Nadex Rule 12, North American Derivatives Exchange, Inc. ("Nadex", the "Exchange") hereby provides notice that due to volatility in the underlying markets upon which the Nadex contracts are based, Nadex added additional strike levels on a discretionary basis in its Daily US Tech 100, Wall Street 30, US SmallCap 2000, Bitcoin Binary Contracts on December 9, 2014.

Additionally, Nadex added additional strike levels on a discretionary basis in its US Tech 100, Wall Street 30, US SmallCap 2000, and US 500 on December 10 and 11, 2014 Nadex returned to its regular listing schedule for all contracts on December 15, 2014.

New strikes created during the week of December 8, 2014 are set forth in Exhibit A.
