RE: Rule Certification: Nadex Amends Hours for 2017 New Year's Holiday and 2017 Holidays – Submission Pursuant to Commission Regulation §40.6(a)

Dear Mr. Kirkpatrick:

Pursuant to Section 5c(c)(1) of the Commodity Exchange Act, as amended (the "Act"), and §40.6(a) of the regulations promulgated by the Commodity Futures Trading Commission (the "Commission") under the Act, North American Derivatives Exchange, Inc. ("Nadex") hereby submits to the Commission its intent to amend its Exchange and listing hours during the week of January 2, 2017 to accommodate the 2017 New Year's holiday and to conform to the listing hours for the underlying market upon which the Nadex contracts are based. Nadex will be closed on January 2, 2017 and plans to implement the amended hours for the open of business on trade date January 3, 2017.

Nadex is also announcing the days the Exchange will be closed in 2017 in observance of public holidays.

Nadex has not identified any DCO or DCM Core Principles that would be negatively affected by the change to the Exchange and listing hours for the week of January 2, 2017.

Pursuant to the 10-day filing period under Regulation 40.6(a)(3), the amendments will become effective January 2, 2017.

The listing schedule for the week of January 2, 2017 is set forth in Exhibit A. The 2018 holiday schedule is set forth in Exhibit B.

No substantive opposing views were expressed to Nadex with respect to these amendments.

EXHIBIT A

Nadex will observe the following modified holiday schedule for the week of January 2, 2017:

Monday, January 2, 2017: The Exchange will be closed on trade date January 2, 2017 in observance of the 2017 New Year's holiday.

Tuesday, January 3, 2017: The Exchange will observe the following schedule:

- Nadex will open at 6:00pm ET time for trade date January 3, 2017. Unless otherwise specified below, all contracts listed on this date will open and close at their regular times.
- With the exception of the Japan 225, all other Weekly contracts will be listed on January 3, 2017 and will have a settlement date of Friday, January 6, 2017, and will settle at their regular times.
- No Japan 225 contracts will be offered on this trade date.
- The Daily Currency 7:00pm ET close time Binary contracts which would normally expire on Tuesday's trade date (Monday evening) will not be listed. All other Daily and Weekly Currency contracts will open at 6:00pm ET or their regular open times, and will close at their regular times.

Wednesday, January 4, 2017: The Exchange will observe regular business hours.

• Daily and Weekly Japan 225 contracts will be listed on this date and will have a settlement date of Friday, January 6, 2017.

All contracts will operate on a normal listing schedule for the remainder of the week.
