Dear Mr. Kirkpatrick:

Pursuant to Commodity Futures Trading Commission (“CFTC” or “Commission”) Regulation 40.6(d), the Exchange submits this weekly notification of the following amendments related to product terms and conditions made effective during the week of December 6, 2021.

On December 6, 2021, the Exchange implemented administrative amendments to the NYMEX Position Limit, Position Accountability and Reportable Level Table (the “Table”) to correct the following typographical errors. Please note that these amendments are simply designed to correct typographical errors and that appropriate aggregation levels have been applied operationally. In the Table, amendments will be made to correct the Contract Names in Column A, for Freight Route Middle East to China (TD3C) (Platts) Futures (Commodity Code TD3), and Freight Route Middle East to China (TD3C) (Platts) BALMO Futures (Commodity Code T3B) (Collectively the “Contracts”). Amendments were made to correct erroneous contract names.

On December 8, 2021, the Exchange implemented administrative amendments to the NYMEX Position Limit, Position Accountability and Reportable Level Table (the “Table”) to correct the following typographical errors. Please note that these amendments are simply designed to correct typographical errors and that appropriate aggregation levels have been applied operationally. In the Table, amendments will be made to correct Spot-Month Column S for European Low Sulphur Gasoil (100mt) Bullet Futures (Commodity Code 7F), LNG Freight Route Australia to Japan RV (BLNG1) (Baltic) Futures (Commodity Code BF1), LNG Freight Route US Gulf to Continent RV (BLNG2) (Baltic) Futures (Commodity Code BF2), and LNG Freight Route US Gulf to Japan RV (BLNG3) (Baltic) Futures (Commodity Code BF3), Japan Crude Cocktail (Detailed) Yen Denominated Futures (Commodity Code JCY), LNG Japan/Korea Marker (Platts) Yen Denominated Futures (Commodity Code JKY), and Argus Propane Far East Index vs. European Propane CIF ARA (Argus) Futures (Commodity Code 91) (the “Contracts”). Amendments were made to correct cells that were previously erroneously not fully populated reflecting the contract’s aggregation.

The Exchange also implemented administrative amendments to the correct Ratio Leg (1) columns N, Y, and AE for LNG Freight Route Australia to Japan RV (BLNG1) (Baltic) Futures (Commodity Code BF1), LNG Freight Route US Gulf to Continent RV (BLNG2) (Baltic) Futures (Commodity Code BF2), and LNG Freight Route US Gulf to Japan RV (BLNG3) (Baltic) Futures (Commodity Code BF3) (Collectively the “Contracts”). Amendments will be made to correct cells that were previously erroneously not populated. LNG Freight Route Australia to Japan RV (BLNG1) (Baltic) Futures aggregate into LNG Freight Route BLNG1g (LNG Fuel) (Baltic) Futures (Commodity Code BL1). LNG Freight Route US Gulf to Continent RV (BLNG2) (Baltic) Futures aggregate into LNG Freight Route BLNG2g (LNG Fuel) (Baltic) Futures (Commodity Code BL2). LNG Freight Route US Gulf to Japan RV (BLNG3) (Baltic) Futures aggregate into LNG Freight Route BLNG3g (LNG Fuel) (Baltic) Futures (Commodity Code BL3). The Spot Month, Single Month and All Month Aggregate Into Ratio Leg (1) columns will be populated to accurately reflect the aggregation of the first leg of the Contracts. Please note that these amendments are simply designed to correct typographical errors and that appropriate aggregation levels have been applied operationally.
