### Re: <u>Cboe Futures Exchange, LLC Rule Certification</u> <u>Submission Number CFE-2021-039</u>

Dear Mr. Kirkpatrick:

Pursuant to Section 5c(c)(1) of the Commodity Exchange Act, as amended ("Act"), and Regulation 40.6(a) promulgated by the Commodity Futures Trading Commission ("CFTC" or "Commission") under the Act, Cboe Futures Exchange, LLC ("CFE" or "Exchange") hereby submits a CFE rule amendment ("Amendment") to recognize Juneteenth National Independence Day ("Juneteenth") as an Exchange holiday by revising CFE trading hours in commemoration of that holiday. Exhibit 1 to this submission sets forth the rule changes included in the Amendment. The Amendment will become effective on January 6, 2022.

On June 17, 2021, Juneteenth was designated a legal public holiday.<sup>1</sup> Juneteenth falls on June 19th of each year. The Exchange will to treat Juneteenth like other Exchange holidays.

In particular, the Exchange plans to exercise its authority pursuant to CFE Rule 402 (Trading Hours) not to have trading hours on Juneteenth in CFE products which only have regular trading hours on normal business days.

The Exchange is also revising its trading hours for the Juneteenth holiday for CFE products which have both regular and extended trading hours on normal business days. Those CFE products include (i) Cboe Volatility Index ("VX") futures, for which trading hours are governed by CFE Rule 1202(b) (Schedule and Prohibited Order Types); (ii) Mini Cboe Volatility Index ("VXM") futures, for which trading hours are governed by CFE Rule 1702(b) (Schedule and Prohibited Order Types); (iii) Cboe AMERIBOR Term-30 ("AMT1") futures, for which trading hours are governed by CFE Rule 1402(e) (Schedule and Prohibited Order Types); (iv) Cboe Three-Month AMERIBOR ("AMB3") futures, for which trading hours are governed by CFE Rule 2002(e) (Schedule and Prohibited Order Types); (v) Cboe AMERIBOR Term-90 ("AMT3") futures, for which trading hours are governed by CFE Rule 2102(e) (Schedule and Prohibited Order Types); (vi) Cboe One-Month AMERIBOR ("AMB1") futures, for which trading hours are governed by CFE Rule 2102(e) (Schedule and Prohibited Order Types); (vi) Cboe One-Month AMERIBOR ("AMB1") futures, for which trading hours are governed by CFE Rule 2102(e) (Schedule and Prohibited Order Types); (vi) Cboe One-Month AMERIBOR ("AMB1") futures, for which trading hours are governed by CFE Rule 2202(e) (Schedule and Prohibited Order Types); (vi) Cboe One-Month AMERIBOR ("AMB1") futures, for which trading hours are governed by CFE Rule 2202(e) (Schedule and Prohibited Order Types); and (vii) Cboe 7-Day AMERIBOR ("AMW") futures, for which trading hours

are governed by CFE Rule 2502(e) (Schedule and Prohibited Order Types).<sup>2</sup>

The Exchange will observe Juneteenth on June 19th. If Juneteenth falls on a Saturday, the Exchange will observe the holiday on the previous day (Friday). If Juneteenth falls on a Sunday, the Exchange will observe the holiday on the next day (Monday).

VX, VXM, and AMERIBOR futures will have extended trading hours from 5:00 p.m. on the day before Juneteenth is observed until 10:30 a.m. on the day that Juneteenth is observed. This is consistent with CFE trading hours on other holidays such as Martin Luther King, Jr. Day. These products will then have normal trading hours on the business day after Juneteenth is observed. Specifically, trading hours for the business day after Juneteenth is observed will consist of extended trading hours from 5:00 p.m. (on the day the holiday is observed or on Sunday if the holiday is observed on Friday) to 8:30 a.m., regular trading hours from 8:30 a.m. to 3:00 p.m., and extended trading hours from 3:00 p.m. to 4:00 p.m. All times referenced in this submission are in Chicago time.

The holiday trading session from 5:00 p.m. on the day before Juneteenth is observed until 10:30 a.m. on the day that Juneteenth is observed will not be a not separate business day and will be part of the next business day. Trade at Settlement ("TAS") transactions in VX and VXM futures will be permitted during this holiday trading session and normal trading hours for TAS transactions will apply on the business day after Juneteenth is observed. The Amendment does not change the provisions that currently apply to the timing of the final settlement date for a VX, VXM, or AMERIBOR futures contract in the event of a holiday or that currently apply to the time of the termination of trading hours for an expiring contract in one of these products on its last trading day.

The rule provisions for VX, VXM, and AMERIBOR futures allow the Exchange to designate one of two alternative trading schedules for the Good Friday holiday. One of those trading schedules (Good Friday Schedule Alternative 1) has no trading hours on Good Friday and the other trading schedule (Good Friday Schedule Alternative 2) provides for a holiday trading session on Good Friday. The rule provisions related Good Friday Schedule Alternative 2 contain further detail regarding the application of these revised trading hours on a Friday. Since those provisions also apply with respect to Juneteenth and Independence Day when those holidays fall on a Friday, the Amendment moves those provisions into a more general set of provisions within each of the applicable rules. This more general set of provisions for Juneteenth, Independence Day, and Good Friday Schedule Alternative 2 without revising the substance of those provisions. Key points included in this more general set of provisions relating to Friday holiday trading sessions that are not already described above include:

- Since a Friday holiday trading session is not a separate business day, trades made during the Friday holiday trading session are submitted for clearing for Monday. Since the time frames between the sessions of trading hours during this business day are a regular feature of this schedule, they are not considered the declaration of a trading halt by the Exchange.
- As is the case with other holiday trading sessions, the applicable daily settlement price is the daily settlement price for the business day. Accordingly, in this case, the applicable daily settlement price is determined on Monday.
- As is also the case with other holiday trading sessions, day orders and quotes entered during

the Friday holiday trading session persist and remain executable during the trading hours on the remainder of the business day, unless they are executed or canceled. Accordingly, day orders and quotes entered during the Friday holiday trading session persist and remain executable during the trading hours on the remainder of the same business day on the Sunday and Monday following the Friday holiday trading session, unless they are executed or canceled.

CFE believes that the Amendment is consistent with the Designated Contract Market ("DCM") Core Principles under Section 5 of the Act. In particular, CFE believes that the Amendment is consistent with DCM Core Principle 7 (Availability of General Information) because the Amendment describes in CFE's rules the trading schedule that will apply in connection with the Juneteenth holiday and the manner in which CFE will implement that trading schedule.

CFE believes that the impact of the Amendment will be beneficial to the public and market participants. CFE is not aware of any substantive opposing views to the Amendment. CFE hereby certifies that the Amendment complies with the Act and the regulations thereunder. CFE further certifies that CFE has posted a notice of pending certification with the Commission and a copy of this submission on CFE's Web site (<u>http://www.cboe.com/us/futures/regulation/rule\_filings/cfe/</u>) concurrent with the filing of this submission with the Commission.

#### 1202. Contract Specifications

(a) No changes.

(b) *Schedule and Prohibited Order Types.* The Exchange may list for trading up to six near-term VX futures expiration weeks, nine near-term serial months and five months on the February quarterly cycle for the VX futures contract. VX futures that have a "VX" ticker are not counted as part of the six near-term expiration weeks.

The final settlement date for a contract with the "VX" ticker symbol is on the Wednesday that is thirty days prior to the third Friday of the calendar month immediately following the month in which the contract expires. The final settlement date for a contract with the "VX" ticker symbol followed by a number denoting the specific week of a calendar year is on the Wednesday of the week specifically denoted in the ticker symbol. For symbology purposes, the first week of a calendar year is the first week of that year with a Wednesday on which a weekly VX futures contract could expire. If that Wednesday or the Friday that is thirty days following that Wednesday is a Cboe Options holiday, the final settlement date for the contract shall be on the business day immediately preceding that Wednesday.

The trading days for VX futures are any Business Days the Exchange is open for trading.

The trading hours for VX futures contracts are set forth in the charts below, except that the trading hours in an expiring VX futures contract end at 8:00 a.m. Chicago time on its final settlement date. The trading hours for VX futures contracts during extended trading hours and regular trading hours shall constitute a single trading session for a Business Day. All times set forth in the charts below are in Chicago time.
