**MOTION FOR APPROVAL AND AUTHORIZATION TO PAY  
INTERIM FEE AND EXPENSE CLAIMS OF RECEIVER  
ROBB EVANS & ASSOCIATES LLC AND ITS COUNSEL  
STINSON MORRISON HECKER LLP, WITH SUGGESTIONS IN SUPPORT**

Comes now Receiver Robb Evans and Associates LLC and moves for approval and authorization to pay its interim fee and expense claims and those of its outside legal counsel, Stinson Morrison Hecker LLP, for the following reasons:

1. On March 18, 2004, the Court appointed Robb Evans and Associates LLC as Receiver for Defendants Wall Street Underground, Inc., et al. in this matter.
2. As described in the accompanying Report of Receiver's Activities, the Receiver determined that Wall Street Underground's ("WSU") account at Euro Bank Corporation belongs to the corporation and safeguarded those assets during the liquidation of Euro Bank Corporation.
3. As detailed in Exhibit A hereto, the Receiver has collected \$1,200,707.37 from the Liquidators of Euro Bank Corporation. To date the Receiver has incurred \$21,790.11 in fees and expenses in collecting said sum. Of the \$21,790.11, \$8,784.00 is for the Receiver's fees. Those fees, for the period March 18, 2004 through November 1, 2005 are supported by the attached signed monthly statements.

4. As detailed in Exhibit B, the Receiver's attorney, Stinson Morrison Hecker LLP, has incurred \$973.50 in fees and expenses during January 2006 in preparing this motion and in filing the accompanying Receiver's report. Stinson Morrison Hecker's fees are supported by the attached signed statement for the period ending January 11, 2006.

WHEREFORE, the Receiver moves for approval and authorization to pay its interim fees and expenses and those of its legal counsel Stinson Morrison Hecker LLP.
