07/08/2024	Dear Ms. Killoy and the Office of the General Counsel, I am writing to appeal the Commodity Futures Trading Commission's decision regarding my and my colleague's Freedom of Information Act Request #24-00181, seeking records or copies of records of communications between officials and staff from the CFTC with representatives of Archer-Daniels-Midland Co from January 1, 2017 to March 22, 2024. The CFTC denied our request in full, citing FOIA Exemption 7(A), 5 U.S.C. § 552(b)(7)(A) "because disclosure of that material could reasonably be expected to interfere with the conduct of federal agency law enforcement activities." The agency further stated that it conducted a segregability analysis and determined there were no reasonably segregable portions to release. But the CFTC made no effort to detail its efforts to obtain these records or provide any meaningful explanation of what that segregability analysis entailed. After consulting with Reuters' legal counsel, we believe the CFTC's blanket denial of our request under FOIA Exemption 7(A), 5 U.S.C. § 552(b)(7)(A) is overly broad. Is your office indicating that every document you obtained with respect to our request pertains to an ongoing investigation? This response is not credible either under the circumstances or the law, and we question whether an adequate search for records and review of such records was conducted. Archer-Daniels-Midland Co is a registrant of the CFTC that would have many reasons for regular communications with agency officials. Thus, a blanket denial under this exemption is insufficient justification. Reuters is appealing your decision on these grounds. We will be mailing a hard copy of this communication to the General Counsel's office. It is also attached to this email.
