## **Addendum: FY 2024 Enforcement Actions**

## Table Summary

The CFTC's FY 2024 enforcement actions include 37 administrative cases, 4 statutory disqualification actions and 17 civil injunctive cases. Most of these enforcement actions involved multiple types of violations, but the table below categorizes the cases by their primary violations.
