Figure 1: IBG LLC Organizational Structure

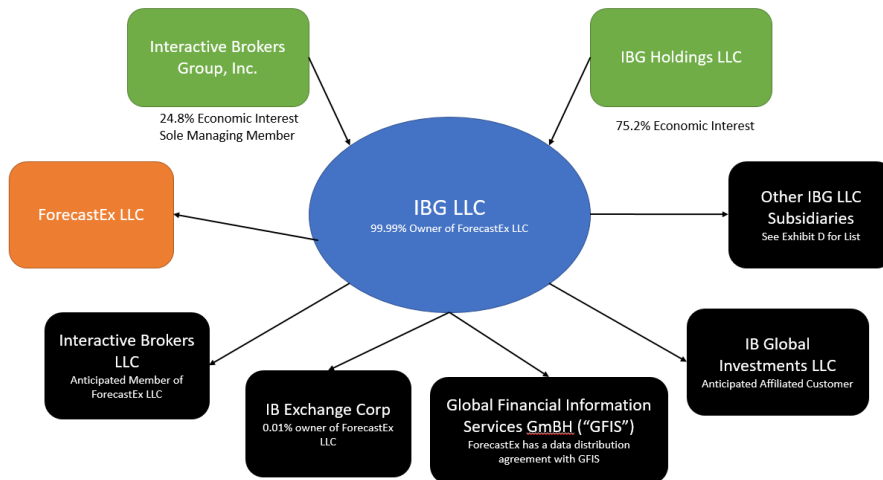


Figure 2: IBG Ownership Structure
