Effective for trade date Monday, July 9, 2007, these amendments include the addition of accountability levels, position limits, and reportable levels for 21 new Petroleum Swap Contracts and 2 new Ethanol Swap Contracts. Pursuant to Section 5c(c) of the Commodity Exchange Act ("Act") and CFTC Rule 40.6, the Exchange hereby certifies that the attached rule amendments comply with the Act, including regulations under the Act.
