Pursuant to Commission Regulation 40.6(a), the Chicago Board of Trade (CBOT[®]) hereby submits the following:

- **Amendment to Rulebook Appendix 2B per the attached text (addition bolded).**

This revision to the Exchange's fee schedule reflects the establishment of an ex-pit surcharge applicable to OTC Ethanol Basis Swap products.

The CBOT intends to implement this amendment as of October 5, 2007, concurrently with the launch of CBOT New York Harbor, Los Angeles and Gulf Coast Denatured Fuel Ethanol Basis Swaps.

There were no opposing views concerning this amendment.
