Schedule for Fifty Two (52) Petroleum Futures and Option Contracts
NYMEX Submission #13-004R**

Dear Ms. Warfield,

The New York Mercantile Exchange, Inc. (“NYMEX” or “Exchange”) is notifying the Commodity Futures Trading Commission (“CFTC” or “Commission”) that it is self-certifying an amendment to the listing schedule for fifty two (52) petroleum futures and options contracts effective for trade date Tuesday, January 22, 2013. There is currently no open interest in these contract months.

Please note that NYMEX is revising NYMEX Submission No. 13-004 to include Special Executive Report (“SER”) #6526, attached as Exhibit A, pursuant to the Commission’s request. Revisions to NYMEX Submission No. 13-004 are attached as Exhibit B with additions underscored and deletions overstruck.

The Exchange has also notified the Commission in a separate submission (NYMEX Submission No. 13-005) of the delisting certain contracts in thirty eight (38) of these contracts, effective close of business today.

Of the fifty two contracts, twenty three (23) are listed for trading on CME Globex and the NYMEX trading floor and for submission for clearing through CME ClearPort, and the remaining twenty nine (29) are listed for trading on the NYMEX trading floor and for submission for clearing through CME ClearPort.
