- Revised electronic trading hours for CBOT Agricultural and Financial contracts as indicated in the attached. (All times shown are Central Time.).

As a result of these changes, electronic trading in CBOT Agricultural and Financial products will open 30 minutes earlier than is presently the case. In addition, all products within a product group will open simultaneously rather than on a staggered basis.

The CBOT intends to implement these trading hour changes concurrently with the transition of these products from the e-cbot® platform to the CME Globex ® platform. The scheduled implementation dates are January 13, 2008 (trade date January 14, 2008) for Agricultural contracts and January 27, 2008 (trade date January 28, 2008) for Financial contracts.
