The New York Mercantile Exchange, Inc. ("NYMEX" or "Exchange") is notifying the Commodity Futures Trading Commission ("CFTC" or "Commission") that it is self-certifying amendments to the Position Limit, Position Accountability and Reportable Level Table located in the Interpretations and Special Notices Section of Chapter 5 of the NYMEX Rulebook in relation to the listing of the new Indonesian Coal (McCloskey sub-bituminous) Swap futures contract. These amendments establish the all month/any one month accountability levels, expiration month position limit, reportable level, and aggregation allocation for the new contract.
