Re: Self Certification of Change to Trading Hours

Dear Ms. Jurgens,

Pursuant to Section 5c(c)(1) of the Commodity Exchange Act (the "Act"), as amended, and Commission Regulation 40.6(a), ELX Futures, L.P. ("ELX") submits, by selfcertification, notification to the Commodity Futures Trading Commission ("Commission") that ELX will implement changes, effective on trade date February 3, 2014, to the Trading Hours for all Eurodollar Futures contracts. ELX is amending the schedule of Pre-Open, Open, and Close times. Pursuant to ELX Rules IV-2 and III-11, ELX will make members aware of these changes through a "Notice to Members" (the text of this Notice is attached as Attachment A).

Description of Rule Amendments

Prior to this change taking effect, ELX's trading hours for the Eurodollar Futures contracts are: (a) Pre-Open at 5:45 p.m. ET the day before the trade date; (b) Open at 6:00 p.m. ET the day before the trade date; and (c) Close at 5:00 p.m. (This schedule is subject to an exception in the case of trading hours modified to accommodate special holiday hours, for which a separate schedule is provided to the public.)

As of February 3, 2014, the schedule for ELX's Eurodollar Futures will be: (a) Pre-Open at 3:45 a.m. ET the day of the trade date; (b) Open at 4:00 a.m. ET the day of the trade date; and (c) Close at 3:00 p.m. (Similar changes have been made to the ELX Holiday Trading Hours schedule for days where trading hours have been modified due to holidays.) ELX is moving to a later Pre-open and Open, and an earlier Close for operational efficiency. This change will be effective for current and subsequently listed products.

A text of the "Notice to Members" advising them of the changes to the trading hours for Eurodollar Futures is attached. Additions have been underlined and deletions stricken through. This notice will be issued to participants on January 15, 2014.

ELX Futures has received no opposing views regarding the changes to the trading hours.

ELX hereby certifies to the Commission, that the rule changes noticed herein comply with the Act, as amended, and the regulations promulgated thereunder; and that a notice of the filing of this submission and a copy of this submission has been posted on ELX's website.

CHANGE TO TRADING HOURS FOR EURODOLLAR FUTURES

Please be advised that ELX Futures, L.P. (ELX Futures) will amend Trading Hours beginning with trade date February 3, 2014. Please note that this change will apply only to the Eurodollar Futures (GEE).

Effective with the change:

- <u>Pre-open will be 3:45 a.m. ET of the trade date beginning on Monday,</u> <u>February 3, 2014 instead of the current 5:45 p.m. ET the day before.</u>
- <u>Regular open will be 4:00 a.m. ET of the trade date beginning on</u> <u>Monday, February 3, 2014 instead of the current 6:00 p.m. ET the day</u> <u>before.</u>
- <u>Regular close will be 3:00 p.m. ET of the trade date beginning on</u> <u>Monday, February 3, 2014 instead of the current 5:00 p.m. ET of the</u> <u>trade date.</u>

Please note that the pre-open and open for trade date Monday, February 3, 2014 will not be on Sunday, February 2, 2014; they will be on Monday, February 3, 2014 at 3:45 a.m. ET and 4:00 a.m. ET, respectively.

ELX Holiday Trading Hours have also been amended to reflect changes to pre-open and open on relevant days.
