> RE: CME Certification and Notification of the Launch Date and Initial Contract Month Listings for the New U.S. Dollar / Turkish Lira Futures and Euro / Turkish Lira Futures Contracts CME Submission No. 09-010

Dear Mr. Stawick:

Chicago Mercantile Exchange Inc. ("CME" or "Exchange") hereby certifies with the Commission the launch date and initial contract month listings for the CME U.S. Dollar / Turkish Lira futures and Euro / Turkish Lira futures contracts. In CME Submission 08-162, dated October 22, 2008, CME submitted to the Commission under Exchange certification, new CME Rulebook Chapters 272, 272A, 320 and 320A, and CME Rulebook Chapter 7 amendments to enable the listing of U.S. Dollar / Turkish Lira futures and options on futures, as well as Euro / Turkish Lira futures and options on futures contracts. However, the Exchange has decided to list initially for trading only the two new futures contracts. At such time as CME determines to launch the U.S. Dollar / Turkish Lira and Euro / Turkish Lira options on futures contracts, it will notify the Commission in a separate submission of the specific launch date and initial contract months. <u>CME Globex<sup>®</sup> trading for the new U.S. Dollar / Turkish Lira futures contracts and the Euro / Turkish Lira futures contracts will begin on Sunday, January 25, 2009, for the trade date of Monday, January 26, 2009.</u>

Six March, June, September and December quarterly cycle contract months will be listed for trading for both of the new futures contracts. The next March cycle contract month not yet listed for trading will listed for trading on the business day following termination of trading for the nearby contract month.

Therefore, on Sunday, January 25, 2009, the initial contract months and listing cycle will be as follows:

Futures: Mar. 2009, Jun. 2009, Sep. 2009, Dec. 2009, Mar. 2010, Jun. 2010.
