RE: Rule Certification: Nadex® Amends its Holiday Trading Hours for the India 50 Contracts for the January 26, 2010 India Republic Day Holiday – Submission Pursuant to Commission Regulation §40.6(a)

Dear Mr. Stawick:

Pursuant to Section 5c(c)(1) of the Commodity Exchange Act, as amended ("Act"), and section 40.6(a) of the regulations promulgated by the Commodity Futures Trading Commission (the "Commission") under the Act (the "Regulations"), North American Derivatives Exchange, Inc. ("Nadex") hereby submits to the Commission its intent to amend its Holiday Trading Hours for the India 50 Contracts for the January 26, 2010 India Republic Day Holiday. Nadex intends to implement this amendment effective for the start of business on trading day Monday, January 25, 2010.

For the India Republic Day on January 26, 2010, Nadex's India 50 contracts will have a modified trading schedule, as follows:

**Tuesday, January 26, 2010:** The Exchange will observe regular exchange hours. No daily India 50 contracts will be offered for trade date Tuesday, January 26, 2010. Weekly India 50 binary contracts will be listed on trade date Monday, January 25, 2010 and will have a settlement date of January 29, 2010, but will not be available for trading on trade date Tuesday, January 26, 2010.

Wednesday, January 27, 2010: The Exchange will observe regular exchange hours. All India 50 contracts offered on this date will open and close at their regular times.

No substantive opposing views were expressed to Nadex with respect to this addition.

Nadex hereby certifies that the revision contained herein complies with the Act, as amended, and the Commission Regulations adopted thereunder.
