Re: Rule 40.6(a) Certification. New York Mercantile Exchange, Inc. Submission #12-036: Notification of Amendment to Listing Schedule for Eight Petroleum Option Contracts

Dear Mr. Stawick:

The New York Mercantile Exchange, Inc. ("NYMEX" or "Exchange") is notifying the Commodity Futures Trading Commission ("CFTC" or "Commission") that it is self-certifying an amendment to the listing schedule for eight (8) petroleum option contracts. The listing schedule for the eight (8) option contracts shall be amended effective Sunday, February 12, 2012 for trade date Monday, February 13, 2012. The options are being expanded such that the listed contract months for the options are aligned with those of the underlying futures contracts.

The Exchange will expand the listing of contract months as set forth in the following contract rules:

- Heating Oil Option Rule 320.03 ("Trading Months for Heating Oil Option Contract")
- Heating Oil Crack Spread Option Rule 350.03 ("Trading Months for Heating Oil Crack Spread Option")
- Heating Oil Calendar Spread Option Rule 392.03 ("Trading Months for Heating Oil Calendar Spread Option")
- Heating Oil Look-Alike Option Rule 551.06 ("Traded and Cleared Months of Heating Oil Look-Alike Option Contract")
- Heating Oil Average Price Option Rule 321.06 ("Trading Months of Heating Oil Average Price Option Contract")
- Heating Oil Crack Spread Average Price Option Rule 523A.06 ("Trading Months")

Daily Publication of Trading Information: NYMEX will continue to comply with this Core
Principle by making public daily information on settlement prices, volume, open interest, and
opening and closing ranges for the additional listing months for the eight option contracts listed
above.

Pursuant to Section 5c(c) of the Commodity Exchange Act ("Act") and CFTC Regulation 40.6 (a), the Exchange hereby certifies that the listing rule amendments comply with the Act, including regulations under the Act. There were no substantive opposing views to this proposal. The amendments will become effective on Sunday, February 12, 2012 for trade date Monday, February 13, 2012.
